Why participate?

- Have a facility in the state of CT

Who is Best Companies Group?

Best Companies Group is an independent research firm specializing in identifying and recognizing great places to work. BCG manages programs like this one all throughout the US, Canada and the UK.

Assessment Description

The assessment is a two-part process designed to gather detailed data about each participating company. Best Companies Group will conduct the surveys, analyze the data and determine the final rankings.

Part I – Employer Questionnaire (EQ): The employer (main company contact) will complete a questionnaire detailing company policies, practices, benefits and demographics. The employer will be asked to complete the survey online.

Part II – Employee Engagement & Satisfaction Survey (EESS): An in-depth set of 78 statements that employees will be asked to respond to using “Agree Strongly” to “Disagree Strongly” (1-5). This survey will also include two (2) open-ended questions, and seven (7) demographic questions. A paper survey option is available, if e-mail and internet technology is not available.

Announcing & Recognizing the Winners!

In December, companies will be notified in writing whether they made the list or not. The list-making companies will be honored at an event in February. A special issue of the Hartford Business Journal that profiles the companies selected as the Best Places to Work in Connecticut will be published in February.
